- Not included**
- meals, accommodations & transportation before or after your package
 - tips and gratuities
 - second caribou or angling licence

A deposit equal to 50% of the hunt cost is required. Deposits may be by cash, check, bank draft, or money order. Deposits are non-refundable, but may be transferred to another hunter that will fill your spot or to a hunt in another year if prior arrangements are made with the lodge manager. The balance of the hunt price is due 60 days prior to the hunt.

Guests who miss the scheduled charter flights are responsible for their own transportation to camp. We recommend that guests plan on overnighing in Thompson the night before their flight to camp and on the day they are scheduled to return to Thompson. Every effort is made for the charter flights to run on time, but safety is paramount and the decision to fly or not is beyond our control. We suggest the purchase of travel insurance.

The Lodge at Little Duck and Tundra Investments Limited make every effort to satisfy our guests. We will assume no responsibility or liability for any hazard of any kind associated with these trips. Neither is any responsibility or obligations assumed for any political, meteorological, climatic, mechanical, or other circumstances or for the actions of transportation companies, contractors or other principals for which The Lodge at Little Duck or Tundra Investments Limited contracts.

All angling and hunting will be carried out in a sporting, fair chase manner, which does not imply or express any guarantee with regards to the harvesting of any game animal. All applicable regulations with respect to angling, hunting and the use of firearms will be strictly obeyed.

I further accept and assume all risks of personal injury or death or loss or damage to property while participating in the said guided excursion, including negligence of The Lodge at Little Duck and their employees, agents, directors and associates.

I acknowledge that I have read the foregoing, and understand that I am relinquishing any and all rights and that I, my heirs, executors or administrators might otherwise have against The Lodge at Little Duck and their employees, agents, directors and associates and that I do so voluntarily.

I acknowledge that this Agreement and any rights, duties, and obligations as between the parties to this Agreement shall be governed solely in accordance with the laws of Manitoba and no other jurisdiction; and any litigation involving the parties to this Agreement shall be brought solely within Manitoba and shall be within the exclusive jurisdiction of the Courts of Manitoba.

I acknowledge that in entering this Agreement, I am not relying on any oral or written representations or statements made by The Lodge at Little Duck or any of their employees, agents, directors and associates with respect to the safety of wilderness travel.
